## **Nolan Principles**

Trustees have considered the Seven Principles of Public Life (The Nolan Principles) and apply these to their role as outlined below.

- **Leadership**: Trustees 'lead by example' in their behaviours and ensure clear and appropriate delegation of responsibilities to the CEO.
- Openness and Accountability: Trustees are open, responsible and accountable to each other, members of staff and other stakeholders about their decisions.
- Honesty & Integrity: Trustees use their knowledge, expertise and experience to take the best
  decisions they can in the interests of the Foundation and should consider taking professional
  advice on any matter of significance where they do not have expertise themselves. Trustees
  declare any private interests relating to their duties and are equally responsible for all
  decisions of the board.
- **Objectivity & Selflessness**: Trustees act in the best interests of the Foundation, ensuring the charity continues to serve the public benefit. Decisions are made on merit and evidence alone.
